## PSC Concentrated Inspection Campaign (CIC) on Safety of Navigation

Paris Memorandum of Understanding (Paris MOU) will launch a concentrated inspection campaign (CIC) on Safety of Navigation. The three-month campaign will be held from September to November and the questionnaire will be published in August, 2017. The campaign shall be conducted simultaneously with the Tokyo MOU.

The purpose of this CIC is to verify that there is compliance with Safety of Navigation, including Electronic Chart Display Information Systems (ECDIS).

Currently the Turkish Flag Administration has commenced the inspections from the beginning of the June which will last until the 30<sup>th</sup> of November in order to be prepared and to avoid any detention for the forthcoming campaign. Inspection will be carried out by the Flag State or by the RO's for all the Turkish Flagged vessels engaged to the international voyages.

When deficiencies are found, actions by the Port State may vary from recording a deficiencies and instructing the master to rectify it within a certain period to detaining the ship until serious deficiencies have been rectified
